Anti-Ragging Committee to ensure compliance with the provisions of regulations as well as the provisions of any law for the time being in force concerning ragging and also to monitor and oversee the performance of the Anti-Ragging Squad in prevention of ragging in the institution. The College Has Constituted the Anti Ragging Committee in The year 2024-25. The following instructions are framed to prevent the menace of ragging and foster healthy interpersonal relations among students in the campus of Pimpri Chinchwad College of Arts ,Commerce and Science. Ragging is strictly forbidden in or outside the college campus. All students shall familiarize themselves with rules/regulations/guidelines on code of conduct, anti-ragging measures and discipline College. All 'new comers' should attend counseling sessions organized for them from time to time by the college staff.

### Objectives

1. To aware the students of dehumanizing effect of ragging inherent in its perversity.
2. To keep a continuous watch and vigil over ragging so as to prevent its occurrence and recurrence.
3. To promptly and stringently deal with the incidents of ragging brought to our notice.
4. 4.To create awareness and sensitivity among the students and staff about strategies of protection and security are in force and that the campus is anti-ragging zone.
5. To identify any tendency or actual act of ragging in case it occurs at the earliest.
6. To provide a easy access to all the students and staff in order to report and approach the night people in case any act of ragging. to take immediate appropriate action as per the intensity of the ragging activity.
7. To provide the freedom of expression in order to report any act of ragging through direct communication, telephonic or virtual mode.
8. To facilitate an environment of fearlessness.
9. To enhance and support the best academic performance and overall personality of students.

## **Functions of Committee**

1. To consider the complaints received from the students and conduct enquiry and submit report to the Anti- Ragging Committee along with punishment recommended for the offenders.
2. Oversee the procedure of obtaining undertaking from the students in accordance with the provisions.
3. Conduct workshops against ragging menace and orient the students.
4. To provide students the information pertaining to contact address and telephone numbers of the person(s) identified to receive complaints/distress calls
5. To create awareness among the students about Anti ragging.
6. To take all necessary measures for prevention of Ragging inside the Campus.
7. Any act of indiscipline, teasing or handling with rudeness.
8. Any act that prevents, disrupts the regular academic activity.
9. Any activity which is likely to cause annoyance, hardship, psychological harm or creates fear or apprehension.
10. Any act of physical abuse causing assault, harm or danger to health.
11. Any act of abuse by spoken words, emails, SMS or public insult etc.
12. Any unlawful assembly or conspiracy to ragging.

## **Punishment to Those Found Guilty**

Any student or group of students found guilty of ragging in the campus or even outside the campus shall be liable to one or more of the following punishments

1. Debarring from appearing in any sessional test / University Examination
2. Suspension from attending classes and academic privileges
3. Withdrawing scholarships and other benefits
4. Suspension from the college
5. Cancellation of the admission
6. Withholding the results.
